

## Supreme Court Ensures Marriage Equality Nationwide

Today, June 26, 2015, the Supreme Court of the United States struck down all remaining bans on marriage for same-sex couples. Justice Anthony Kennedy, writing for the majority in *Obergefell v. Hodges*, said "The Court, in this decision, holds same-sex couples may exercise the fundamental right to marry in all States. It follows that the Court also must hold-and it now does hold-that there is no lawful basis for a State to refuse to recognize a lawful same-sex marriage performed in another State on the ground of its same-sex character."

From 2013-2014, the HASPS trial team of <u>Mark Aronchick</u>, John Stapleton, <u>Dylan Steinberg</u>, and <u>Rebecca Melley</u>, and HASPS family law expert, <u>Helen Casale</u>, along with the ACLU of Pennsylvania, the ACLU LGBT Project, and University of Pennsylvania School of Law Professor Seth Kreimer, led the fight in *Whitewood v. Wolf*, which brought marriage equality to Pennsylvania. One day after the Honorable John E. Jones III invalidated Pennsylvania's ban on same-sex marriage in a strongly worded decision, then Governor Thomas W. Corbett, Jr. announced that Pennsylvania would not appeal. *Whitewood*, including Governor Corbett's decision to not appeal, was hailed as a key moment in the nationwide push for marriage equality.

Since *Whitewood*, thousands of couples and families in Pennsylvania have obtained the benefits, protections, and dignity that only the unique institution of marriage affords.

"We salute the brave families who served as plaintiffs in *Obergefell* and all other marriage equality cases through the country. Helen Casale, a leading family law and LGBT rights expert noted that *Obergefell* directly benefits families already living in marriage equality states. She said, "*Obergefell* is still critical even for families in Pennsylvania and New Jersey. The Supreme Court has solidified the decisions that brought marriage equality to this region, erasing any ambiguity or lingering unease those couples may have had. And now, those couples know that they can travel freely to all fifty states and not fear that their marriage will vanish merely by crossing certain state lines."
